## > CONFIRMATION OF PLACEMENT REQUEST FORM

**If you are studying at an Education provider in Western Australia you will require a Confirmation of Placement from the Department of Education in Western Australia to secure your child's dependent visa. This Confirmation of Placement does not guarantee you an enrolment in a Public Primary or Secondary school.**

TAFE International Western Australia manages the placement of overseas fee-paying students on behalf of the Department of Education.

To receive a copy of your Confirmation of Placement you are required to provide the following documents to TAFE International Western Australia:

- > Completed Confirmation of Placement Request Form
- > Confirmation of Enrolment (COE) for the Primary visa holder
- > Copy of the Primary visa holders passport details page
- > Copy of the child/children's passport details page

### 2018 FEES

**Mainstream tuition fees for overseas fee-paying students (including holders of scholarships that also sponsor dependant children). These fees(only) are waived for students enrolled in full-time postgraduate Masters & PhD studies at a recognised Western Australian university for the duration of their studies only. All other additional fees, contributions and charges apply.**

#### Fees in addition to tuition fees

##### Fees for specialist provision or support for students with a disability

Students with disability may require additional support to participate in an educational program. Prior to enrolment, the level and costs are determined on a case-by-case basis by the relevant School of Special Education Needs. The maximum parent contribution for a student requiring specialist disability support is \$25,000.

##### English Language Support

Additional fees will be charged to meet the cost of access to additional language support. The fee for an Intensive English Centre is \$3,000 per year and the fee for English as a Second Language (ESL) support is \$1,500 per year.

#### Other contributions, charges and fees

In addition to tuition fees and fees for specialist support, overseas students must pay the following directly to the school:

- > contributions, charges and fees that are payable by local students enrolled at the school;
- > Personal items such as school and sports uniforms, items for individual student use, stationery, travel to and from school, excursions/incursions, books, swimming programs and optional courses of study all incur additional fees;
- > leasing or purchasing notebook computers and the School Curriculum and Standards Authority Fee.
